Subject: Information obtained pursuant to Article 69(1)(2) of the Act of 29 July 2005 on Public Offering

Following the above-mentioned event, all funds managed by the Society do not hold any shares in the Company.

There are no persons referred to in Article 87(1)(3c) of the Act.

At the same time, the Society informs that the funds managed by the Society do not hold financial instruments referred to in Article 69b(1) of the Act."
